

**CBI Policy & Signature Waiver**  
**Updated for Summer 2021**

**Assumption of the Risk, Waiver and Release of Liability Relating to COVID-19**

The World Health Organization has declared COVID-19 a worldwide pandemic. **COVID-19 is known to be highly contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, local governments and federal and state health agencies recommend physical distancing and additional measures to limit the spread of COVID-19 and have continued to recommend limiting large gatherings.

**Chanen Preschool and Congregation Beth Israel (“Chanen”)** have put in place preventative measures to reduce the spread of COVID-19; however, given, among other things, the long incubation period of COVID-19 and the fact that many infected people are asymptomatic, Chanen **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending Chanen could increase** your risk and your child(ren)'s risk of contracting COVID-19.

As used in this Agreement, “Chanen” includes Chanen Preschool, Camp Chanen, Congregation Beth Israel and all past, present or future parent(s), subsidiaries, joint ventures, affiliated entities, related entities, successors in interest, predecessors in interest, insurers, and any current or former legal representatives, and other agents, directors, officers or employees.



By signing this Agreement, I acknowledge and represent that I understand the contagious nature of COVID-19 and, on behalf of myself and my children and any personal representatives, heirs, assigns, and next of kin, **I voluntarily assume all risks, known or unknown, that my child(ren), other family members, and I may be exposed to or infected by COVID-19 by my child(ren) attending Chanen** and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I agree and represent that my child[ren]'s attendance at Chanen is wholly voluntary. I understand that the risk of becoming exposed to or infected by COVID-19 at Chanen may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Chanen employees, volunteers, and program participants and their families.

IN CONSIDERATION for my child being permitted to attend and use the services and facilities of Chanen, I acknowledge, agree, and represent, on behalf of myself and my children and any personal representatives, heirs, assigns, and next of kin (hereinafter collectively “Participants”), that I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury or illness to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, lawsuits or expense, of any kind, that I, my child(ren), or other family members may experience or incur in connection with my child(ren)'s attendance at Chanen or participation in Chanen programming (“Claims”).

On my behalf, and on behalf of my child(ren) and any personal representatives, heirs, assigns, and next of kin, I hereby release, covenant not to sue, discharge, and hold harmless Chanen, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind, including attorneys' fees and costs, or any rights whatsoever, arising out of or relating in any way to my child(ren)'s attendance at Chanen. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Chanen, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Chanen program. I understand and agree that this waiver and release is intended to release Chanen from all claims, including negligence, to the fullest extent permitted by law.

I further agree to defend and indemnify Chanen for all claims, damages, losses, or expenses, including attorneys' fees, if the suit is filed concerning an injury, illness, or death to me, my child(ren), or my household members resulting from my child(ren)'s attendance at Chanen.

I further agree to abide by the procedures established by Chanen to protect its students, families, and staff, including but not limited to always wearing a mask when on CBI's campus, following the drop-off and pick-up procedures and maintaining physical distancing of at least six (6) feet. I further agree that I will not bring my child(ren) to Chanen if my child(ren) or other family members have a fever, are showing signs of COVID-19, have tested positive for COVID-19, or have symptoms of any illness, and will not return my child(ren) to Chanen until after they have been cleared by a health care provider or completed the self-isolation recommendations from the Centers for Disease Control.

I HAVE CAREFULLY READ AND VOLUNTARILY SIGN THIS ASSUMPTION OF RISK AND WAIVER AND RELEASE OF LIABILITY AND FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE. I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM GIVING UP VALUABLE LEGAL RIGHTS, INCLUDING, BUT NOT LIMITED TO, THE RIGHT TO RECOVER FOR EXPOSURE TO COVID-19 AT CHANEN OR ANY ILLNESS, INJURY, OR DEATH RESULTING THEREFROM. I UNDERSTAND THAT THIS DOCUMENT IS A PROMISE NOT TO USE AND A RELEASE OF AND INDEMNIFICATION FOR ALL CLAIMS. I ALSO UNDERSTAND THAT THIS AGREEMENT IS MADE ON BEHALF OF MYSELF AND MY MINOR CHILD(REN) AND I REPRESENT THAT I HAVE FULL AUTHORITY TO SIGN THIS AGREEMENT ON BEHALF OF SUCH MINORS.

ADDITIONALLY, I give permission to any representative of Chanen Preschool/ or CBI to sign my child in or out of childcare each day. This representative may sign on my behalf or that of another authorized party that I have previously designated via the Emergency, Information and Immunization Record Card held on file at Chanen Preschool.
